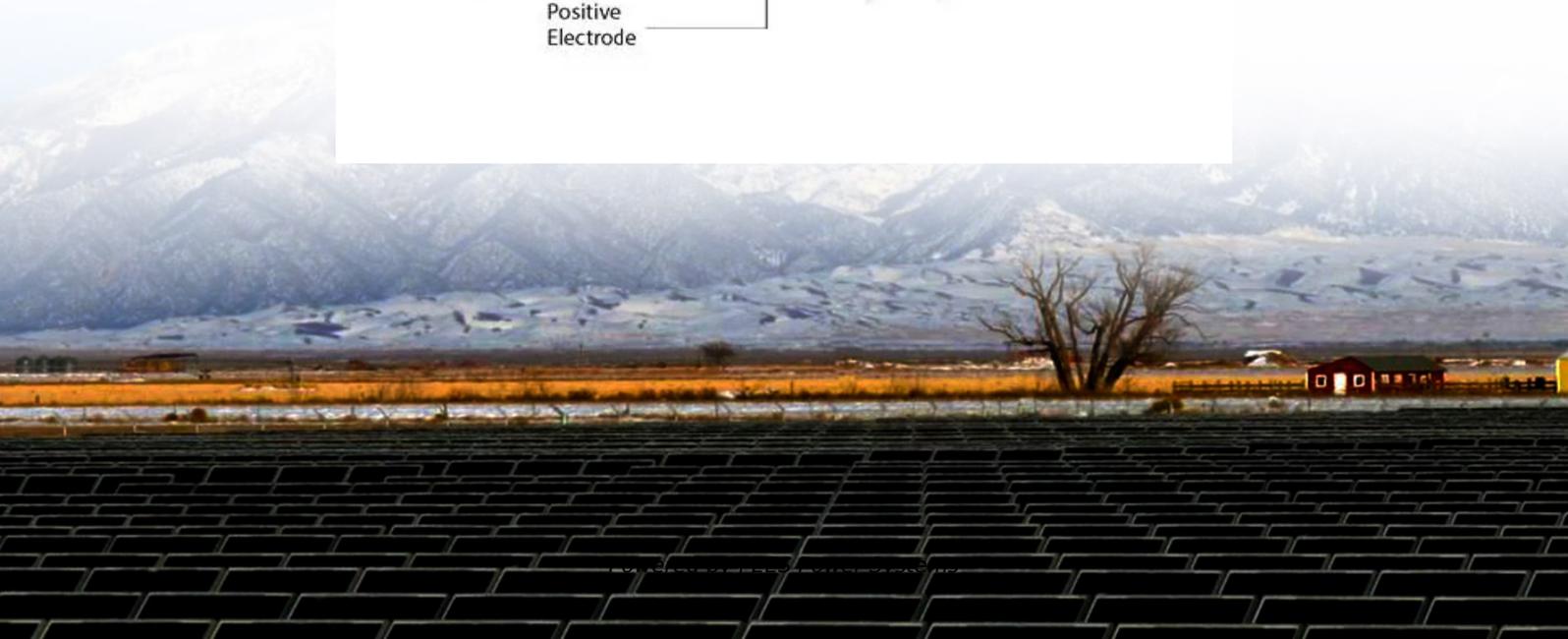


# Are solar battery cabinet lithium battery packs prohibited items



## Overview

---

As of Ma, new TSA rules prohibit passengers from packing portable chargers, power banks, and cellphone battery charging cases that contain lithium-ion batteries in checked luggage. This rule also applies to spare external lithium batteries. From lithium batteries to aerosol whipped cream, many items used every day at home or work are regulated as hazardous materials (a. "hazmat" and "dangerous goods"). These products may seem harmless; however, when transported by air they can be very dangerous. In fact, a lithium battery fire caused the crash of UPS Flight 6 in 2010, which was a Boeing 747 that was known for carrying huge cargo loads and was carrying several pallets containing. Gas-powered generators are only accepted as checked items if they are new, unused, and in original packaging.

### **Shipping Restrictions & HAZMAT**

If you're mailing pre-owned, damaged, or defective electronic devices containing or packaged with lithium batteries, you must send them via ground transportation; they are prohibited in air transportation.

## Lithium Batteries in Baggage

Spare (uninstalled) lithium metal batteries and lithium-ion batteries, portable rechargers, electronic cigarettes, and vaping devices are prohibited in checked baggage. They must be carried with the ...



## Battery or Fuel-Powered Items , Delta Air Lines

Passengers are permitted to travel with lithium ion batteries that contain a maximum of 160-watt hours per battery. Any lithium ion battery containing more than 160-watt hours is prohibited from carriage on all ...

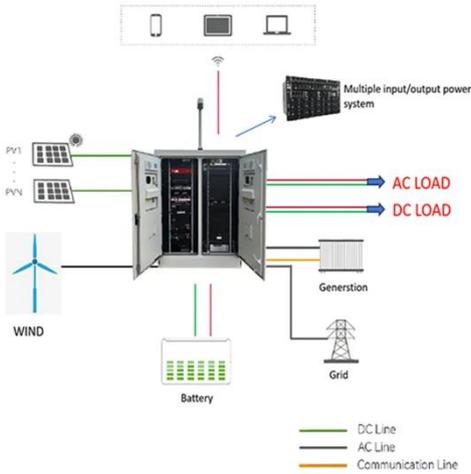
