Solar power has emerged as a game-changer in Northwest Georgia, with both residential and commercial sectors investing in photovoltaic (PV) systems. Several factors contribute to the rising adoption of solar energy: If you use a solar panel system — also called a photovoltaic or PV system — to produce electricity, you buy less electricity from the utility company and enjoy the benefits of renewable energy. The Department of Energy says most homes with solar panels get at least 40% of their energy from solar; Currently, Georgia has a poorer state of solar panel adoption than other states. It is due to reduced benefits and problems with local legislation. During the 2024 session, an industry-supported decommissioning bill was passed after much collaboration and effort.
