# Does solar panel electricity need to be taxed

Photovoltaic systems must provide electricity for the residence, and must meet applicable fire and electrical code requirements. Tax Credit includes installation costs. Use these steps for claiming a residential clean energy tax credits. Make sure the property on which you are installing the energy property is eligible: Make sure you are installing qualified energy property: Used (previously owned) clean energy property is not eligible. The credit for solar upgrades was extended through 2025, empowering more homeowners to switch to solar. Find out if you qualify and learn how to claim the solar tax. You claim the solar tax credit by filing IRS Form 5695 with your federal tax return, allowing you to deduct 30% of your solar installation costs directly from your tax bill. For most homeowners, that means this credit is no longer accessible due to limited installer capacity heading into year-end.

### Federal solar tax credit in 2025: How does it work?

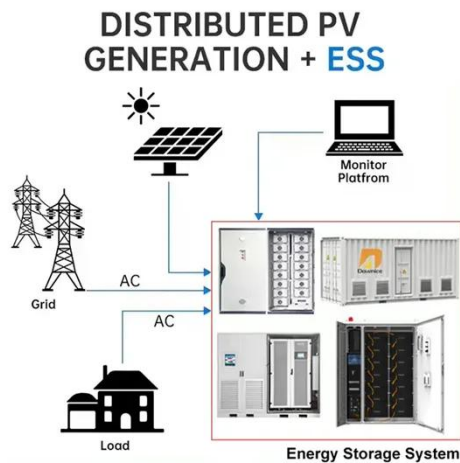
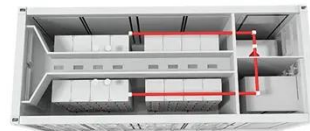

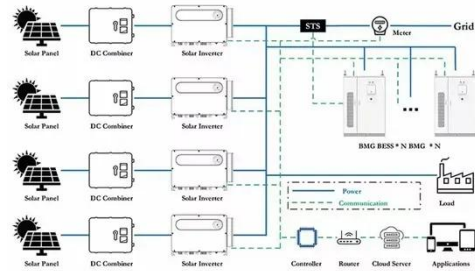
