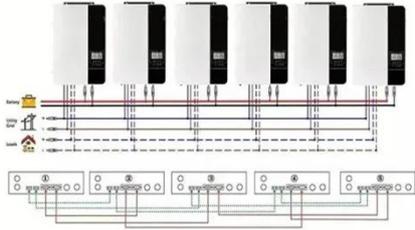

On 9 January 2026, China's Ministry of Finance announced a significant adjustment to its export tax rebate policy. Over the transition period from 1 April 2026. China will scrap value-added tax export rebates for PV products from Ap, while cutting battery rebates ahead of a full phaseout, raising export costs for manufacturers and potentially pulling shipments forward into early 2026. 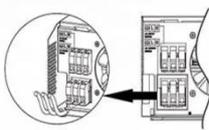


