# How much is the tariff exemption for solar panels in Tonga



## Overview

---

A duty exemption could reduce this to just the 15% CT, representing a direct saving of \$20,000. Obtaining a duty concession is a formal process that requires proactive engagement with Tongan government bodies. Consumption Tax (CT): A standard rate of 15% is applied to the value of imported goods. However, the Tonga Energy Road Map (TERM) provides a framework to support investments in the renewable energy sector. Projects aligned with these national objectives may be eligible for significant duty. Please note that in addition to duties and taxes, you may be required to pay a processing fee as well as 15% Taxes Consumption Taxes Payments in bank notes and coins will only be accepted in Tongan pa'anga and seniti. The rates at which these duties are assessed can vary depending on the type of product and its origin.
