# How much is the tax refund for photovoltaic panels in Brazil



## Overview

---

From 2024 to 2027, photovoltaic modules assembled in Brazil will be subject to a 10.8% tax on imported solar panels. The replacement of taxes such as ICMS, ISS, PIS, and COFINS by CBS and IBS represents more than a simplification—it is a shift in the foundational structure of the tax system. Law 14,300/2025, which regulates Brazil's Tax Reform, the scenario changes. Companies that qualify for PADIS receive exemptions from three major federal taxes. IPI is a federal value-added tax levied on manufactured goods, both domestic and imported. The shadow of new protectionist measures also wraps Europe, but the solar sector is split in two – Support local production by curbing Chinese power in the field of green technologies. With Law 14,300 and the new solar tax in 2025, understand how these tax benefits enable cost reductions, facilitate financing and increase the sector's attractiveness to investors, fostering economic growth. 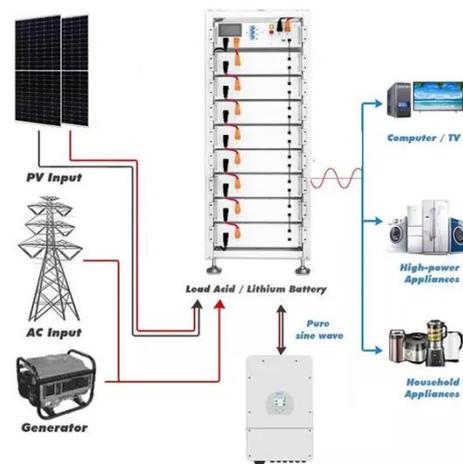
