Yes, most solar panel installations require permits. Whether you're installing rooftop panels or a ground-mounted system, local building departments typically require permits to ensure safety, code compliance, and proper grid connection. Solar, or photovoltaic (PV) panels as they're referred to in NFPA 1, Fire Code, are becoming more and more common on one- and two-family dwelling and townhouse roofs. Since the 2016 edition of NFPA 1, access pathways have been required on roofs to facilitate fire service access as well as egress. Understanding these regulations before installing solar panels ensures compliance, maximizes financial benefits, and prevents costly mistakes. While the Florida Solar Rights Act, codified in Section 163.04 of the Florida Statutes, prohibits governmental bodies and private organizations from enacting regulations that unreasonably restrict the use of solar energy systems. Placing PV panels on residential roofs is a balancing act between getting the most possible wattage and creating safe pathways for first. Not everyone is on board with solar panels, though.
