The Easy Permit Process is administered at the EPP Permit Desk located in Room 906 at City Hall at 121 North LaSalle Street Chicago. The Applicant must be a Solar Contractor / Installer approved to participate in the Photovoltaic Solar Panel Program. Following the installation, a professional from the local government. permit is required for the structural support of all solar energy sy  
acing for supports of the solar energy devices shall be 48" on center. Racking systems shall be anchored to solid wood roof rafters or to solid wood blocking with a minimum of one 5/16" diameter lag screw embedded a minimum of  $\frac{1}{4}$ ". Before starting any solar panel installation, battery storage upgrade, or PV system expansion, you'll need approval from your Authority Having Jurisdiction (AHJ). Solar permitting requirements vary widely across the U., depending on state, city, county, and utility company rules.
